**PENALTIES:**

SECTION 27-17-467 Provides that if any person fails to obtain a privilege license or renewal license, then the taxpayer is liable for the amount of the privilege tax plus a penalty of 10% and thereafter a penalty if 1% per month for each month or part thereof during which the tax remains delinquent. It is the duty of the tax collector to collect all privilege taxes levied and imposed. In all cases where the privilege license remains

delinquent and unpaid for 30 day or more, the tax collector shall have the authority and the power to proceed to collect the tax from any person liable therefor, and the tax collector has full authority to make any and all assessments that might be required or necessary, to bring any suits or actions in any court of competent jurisdiction, and to do all other things which might be necessary for such purpose.

Further, Section 27-17-521 provides that anyone violating the provisions of this chapter is guilty of a misdemeanor, and upon conviction, is to be fined up to \$500 or imprisoned up to 6 months, or both. Municipality may enforce criminal proceedings while at the same time seeking to collect the tax due.

The statute also provides that the officer required to collect the tax may seize and sell any property of such person liable for such tax and penalty.
